Each plain ended pipe is to be supplied with one free coupler conforming to IS:7834(Part-VI)/1975 or IS:10124(Part-I)/1992. Each pipe is to be supplied with adequate quantity of solvent cement conforming to IS:14182/1994. Quantity being allocated herewith is 100.00 M.T.

Formal supply order and dispatch instructions will be issued by the consignees concerned.

Important and relevant terms and conditions as agreed upon have been reproduced in Annexure-B of this allocation order for your attention and benefit of the consignee(s) and shall be treated as an integral part of this allocation.

2. Rates for supplies as allocated herein shall be governed especially by Clause-16 of the agreement. Excise Duty Exemption Certificate shall be Provided by the consignee as per Government Notification No. 12/2012 Central Excise dated 17/03/2012 issued by District Magistrate, hence Excise Duty is NIL. UP VAT @ 5.00% (including SAT @1.00%) will be paid extra. VAT shall not be chargeable on FREIGHT ELEMENT. Details of freight element are given in Annexure-A.

3. Validity date of the agreement under reference is 12/04/2017 and as per Clause-23.1.1 of the agreement it car be extended only if the undersigned and you are in mutual agreement. As such payment against supplies effected after this validity date shall be released by the consignee(s) only after getting clearance for the same from this end.

4. As per clause 21.1 of the agreement supplies as mentioned herein should be started within a week' time in materials are available in ready stock otherwise within four weeks time positively. In case a request from any consignee(s) is received for shortening the so stated delivery period on grounds of any special reason, the supplier shall make all out efforts to complete the supplies within the desired time frame work and not give any opportunity to consider imposing clause-28 of the agreement pertaining to LIQUIDATED DAMAGES ETC.

Crown Agents in advance @ 0.85% (Service Tax extra as applicable) of Ex-Works Cost of Pipes (excluding VAT and Freight) to be inspected since they are included in your rates.

7. You are required to maintain density of P.V.C. Pipes as 1.40 to 1.46 grams/cm<sup>3</sup> positively (As per clause 10.6 of IS:4985/2000) failing which the pipes will not be accepted at all. Density test shall also be carried out by the inspecting agency along with other parameter provided in IS:4985/2000 or its latest amendment(s).

8. As per clause 33.9 of the agreement you shall have to provide facility of utilising testing equipment and machinery available in your unit with your technical staff to be used by Inspecting Officer of U.P. Jal Nigam or by Third Party Inspection Agency without charging any extra cost for carrying out required tests.

9. The material should only be supplied if your license for ISI Marking is valid on date of supply of

material.

10. You have to furnish to Consignees, documented detail(s) of Service Tax paid in the process of commencement of supplies to service providers such as transporters etc.
