4. If there is a holiday, on the date of opening of tender, the same shall be opened at the same time on next working day.
5. The earnest money must be enclosed in separate envelop with the tender in shape of FDR/CDR of a Nationalised Bank or NSC of post office duly pledged in favour of Project Manager-III, Ganga Pollution Control Unit, U.P.Jal Nigam, Kanpur. Tender without proper earnest money shall not be considered.
6. If tender documents are required by post, then an additional charges of Rs 500.00 shall have to be paid by the contractor. The department shall not be responsible for any postal delay.
